In the reference 4<sup>th</sup> cited, the school has got Provisional Recognition to classes 10 years from 2014-2015 to 2023-2024.




After careful examination of the proposals vide reference 5<sup>th</sup> cited, and the conditions prescribed in the G.Os 1" and 3" read above, the District Educational Officer, Palnadu is hereby accorded Renewal of Recognition for a period of 08 years for classes Nursery to V (E.M) commencing from the academic year i.e., from 2024-2025 to 2031-2032 in respect Veenus Primary School, 14th Mile, Lemalle, Amaravathi Mandal, Palnadu District subject to the fulfillment of the following conditions.

- 1) That the society shall abide by the rules and regulations made in the Government orders in 1<sup>st</sup> to 2<sup>nd</sup> read above cited above and also issued from time to time.
- 2) That the Educational Institution shall needs of the locality more particularly.
- 3) That the Institution shall adopt curriculum and syllabus prescribed from time to time by the Govt., of AP.
- 4) That the school timings, vacations and midterms holidays shall be prescribed by the government from time to time.
- 5) That the qualified staff with in the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
- 6) That the results of the institution shall be satisfactory of every year.
- 7) That the records / accounts, annual administrative report along with the audited accounts should be submitted to the District Educational Officer, every year.
- 8) That the list of Governing Body shall be furnished to the D.E.O., every year.
- 9) That the pay structure / fee structure fixed by the Governing body shall be submitted to the District Educational officer every year.
- 10) That all the conditions prescribed in the G.Os and other orders which are not specified in this orders shall be complied with.

- 11) That the school shall not be closed without giving notice both to the parents / Dist.Ednl, Officer, and the competent authority at least 6 months before.
- 12) That the school shall be closed (or) permitted to be closed only from the date on which summer vacation is declared.
- 13) That the society shall submit proposals for renewal of Provisional Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of recognition.
- 14) The school management is requested to submit an affidavit every year with regard to non violation of rules / regulations prescribed by the Government from time to time.
- 15) The management is requested to submit renewal Structural Soundness Certificate and NOC issued by the Fire Service Department before expiry of certificates validity to this office every year then only further ETR will be granted without proposals.
- 16) The management is requested to renew the play ground period after expiry of the date.

- 6.That the results of the Institutions shall be satisfactory every year.
- 7.That the records/accounts shall be furnished to the D.E.O every year.
- 8.That the list of Governing Body shall be furnished to the D.E.O. every year.
- 9.That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
- 10.That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
- 11.That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
- 12.That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13.That the society shall submit a proposal for Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal of recognition.
- 14.The Renewal of Recognition now given is purely on a temporary basis and is subject to the reports of the State Level Inspection and Vigilance Committee fulfilling all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfilled any prerequisites as stipulated, the Renewal of Recognition now being given is liable to be withdrawn at once.
- 15.The Management is requested to follow the instructions of the Fire Department and Renewal the Fire Certificate from time to time without fail and submit the same to this officer through the Deputy Educational Officer, Sattenapalli, Palnadu District and the District Educational Officer, Palnadu.
- 16.The Management is requested to renew the Vehicle Fitness Certificate, NOC issued by the Traffic Police and also obtain Structural Soundness Certificate and Sanitary Certificate every year from the concerned authorities without fail and submit the same to the District Educational Officer, Palnadu Through the concerned Deputy Educational Officer, Sattenapalli, Palnadu District.
- 17.Economic Strength should be maintained in all classes and it should be improved during this academic year.

Further, the managing committee of the school is requested to fulfill

all requirements to cope with the needs of the institution at the Latest before submitting of application for Renewal of Recognition for the year 2032-2033.
